## SUPPLIER REGISTRATION FOR THE YEAR 2026

Galoya Plantations (Pvt) Ltd was formed in the year 2007 as a joint venture between the Government of Sri Lanka (GOSL) and a consortium of private sector investors comprising of Brown & Company PLC and Lanka ORIX Leasing Company PLC, where 51% of the ownership is with the Government of Sri Lanka and 49% of the ownership is with the consortium in order to revitalize former Hingurana Sugar which was closed down for more than 15 years.

Galoya Plantations consists total land extent at 9,300 ha & currently cultivating 6,900 ha providing 1,300 direct employments 40,000 indirect employments & serving more than 9,400 farmers to uplift their livelihoods.

Galoya Plantations (Pvt) Ltd is known as Hingurana Sugar Factory which produces mainly brown sugar. Annual sugar production of 33,000 MT contributes to 1/3 of the local production. For the production of 33,000 MT sugar, Galoya Plantations (Pvt) Ltd purchase about of 469,000 MT of sugarcane annually grown by local farmers by providing necessary agri-inputs, providing trainings and extension activities, buying back their products and maintaining better relationship with them.
